









Gelecek Varlık Overview

Gelecek Varlık is a publicly listed company with 18 years of investment and collection experience in the market

Company Overview

- > Founded under the name Girişim Varlik Yonetimi, Gelecek Varlik Yonetimi engages in provision of financial services by operating in the field of debt resolution by purchasing non-performing loan of banks and other financial institutions.
- The company was founded by Fiba Holding in 2005 and is headquartered in Istanbul, Türkiye
- As of 31 March 2024, the company has 563 employees.
- **Ownership**: Fiba Holding c.69.9%, Murat Özyegin c.5.6%, Aysecan Özyegin Oktay c.5.6%, free float c.19%
 - Since 31st March 2024, the Company is listed in Borsa Istanbul stock exchange with a current market capitalisation of 5.92 Bn TL
- ▶ **Market Positioning**: Gelecek Varlık is the leader in the NPL purchase / servicing space, with a cumulative market share of c.24,8% and preserves market leadership in total principal amount, total investment & total collection.
- ▶ Management: Sezin Ünlüdoğan has been serving as the CEO of Gelecek Varlik since 2016. Top Management has 13+ year Asset Management & 19+ years financial industries experience






Collection Strategy
